



Terms and Conditions of sim Credit Card - RentSmart ("Merchant") \$0 Service Fee Promotion ("Promotion")

1. The promotion period of this Promotion is from 17 March 2026 to 31 July 2026 (both dates inclusive) ("**Promotion Period**").
2. This Promotion is only applicable to principal cardholders ("**Eligible Cardholder(s)**") of the sim Credit Card / sim World Mastercard® ("**Eligible Credit Card**") issued by United Asia Finance Limited ("**Card Issuer**").
3. Subject to Clause 4 below, Eligible Cardholders must successfully register a Rentsmart account via the RentSmart mobile app ("**Merchant App**") during the promotion period to qualify for participation.
4. "**Eligible Transaction**" is defined as **a single transaction of HKD5,000 or more made via the Merchant App during the Promotion Period and posted in Hong Kong dollars on or before 14 August 2026** (that the definition is based on the merchant codes or transaction categories determined by the related card associations worldwide, the acquiring bank of individual merchants or the Card Issuer); **but shall not include** reload/ transfer/ payment transactions made via or in relation to electronic wallets (including but not limited to Alipay, WeChat Pay, PayMe), reload of stored value accounts, instalment amount, unposted transactions, cancelled transactions, returned transactions, counterfeit transactions or any other unauthorized transactions.
5. During the Promotional Period, Eligible Cardholders who complete an Eligible Transaction using their Eligible Credit Card via the Merchant App will be entitled to the offer ("**Offer**") below:

- i. An instant waiver of the 1.5% merchant service fee ("**\$0 Service Fee**") for a single Eligible Transaction of HKD5,000 or more. The \$0 Service Fee applies only to the first Eligible Transaction each calendar month. Each Eligible Cardholder can enjoy the \$0 Service Fee up to maximum of three (3) times throughout the entire Promotional Period, with a maximum monthly waiver of HKD300 which equates to a **transaction amount cap of HKD20,000**. Eligible Cardholders will remain responsible for any service fees incurred on transaction amounts exceeding HKD20,000.

Example:

Eligible Transaction amount	Service fee payable to the Merchant
HKD20,000	HKD0
HKD23,000	HKD45

- ii. An additional HKD150 cash rebate ("**Cash Rebate**") on a single Eligible transaction of HKD15,000 or more. Each Eligible Cardholder can enjoy the Cash Rebate once per calendar month, up to a maximum of three (3) times throughout the entire Promotion Period.
6. The Card Issuer's records with respect to the Eligible Cardholder on the amount of Eligible Transactions from time to time are conclusive and binding against the Eligible Cardholder. All Eligible Transactions shall be determined based on the merchant codes or transaction categories assigned by the related card associations worldwide, the acquiring bank of individual merchants or the Card Issuer and may be varied from time to time without prior notice. If there is any dispute surrounding any Eligible Transactions, the decision of the Card Issuer shall be final and conclusive.
 7. If an Eligible Cardholder is issued and holds multiple Eligible Credit Cards at the same time, the Eligible Transaction amount will be calculated separately for each Eligible Credit Card account. Each Eligible Cardholder can only receive the Offer up to a maximum of three (3) times throughout the entire Promotion Period.
 8. Eligible Transactions shall be determined at the sole and absolute discretion of the Card Issuer. The Card Issuer has no obligation to clarify which transactions are eligible for the Promotion before the transactions are made.
 9. For the avoidance of doubt, use of mobile payment services (if applicable) in connection with an Eligible Credit Card shall be subject to the applicable terms and conditions governing the use of such services. For details, please visit the [sim Credit Card website](#).



10. If the Eligible Cardholder is verified by the Card Issuer and confirmed to be qualified for the Cash Rebate, the Cash Rebate will be automatically awarded to the Eligible Credit Card account of the principal cardholder by the Card Issuer on or before 30 September 2026.
11. The Eligible Credit Card account must be valid and in good standing during the entire Promotion Period and at the time of delivering the Cash Rebate in order to enjoy the Cash Rebate. Otherwise, the Cash Rebate will be forfeited.
12. In case of any Eligible Transactions used to calculate the Offer are subsequently cancelled, reversed, refunded or found fraudulent or abused, the Card Issuer reserves the absolute right to debit the full amount of the \$0 Service Fee or the equivalent amount of the awarded Cash Rebate hereunder from the Eligible Credit Card account, forfeit the relevant Eligible Cardholder's eligibility to participate in this Promotion, and/or suspend the relevant Eligible Credit Card account for investigation without prior notice.
13. Eligible Cardholder must keep the electronic records of all posted transactions. The Card Issuer reserves the right to request Eligible Cardholder to provide the relevant electronic records for verification. All sales slips submitted to the Card Issuer will not be returned.
14. The Offer (i) is not transferable, exchangeable or refundable, (ii) is not redeemable or exchangeable for cash and cannot be withdrawn as cash, and (iii) cannot be applied against the statement balance or the amount of a single transaction or part thereof in the statement of any credit card.
15. If an Eligible Cardholder is eligible for the benefits under any other promotional activities of the Card Issuer during the Promotion Period, the Card Issuer may in its sole and absolute discretion decide to only provide the Eligible Cardholder with the promotional benefits under one of the promotions.
16. The Card Issuer shall not be liable for any loss, damage or injury suffered by the Eligible Cardholder arising from the participation in the Promotion or the use of the offers thereunder.
17. The Card Issuer is not the supplier of the Merchant's services and makes no representations or guarantees regarding any relevant services. The Card Issuer shall not be responsible for or guarantee the quality or the quantity of supply, and fitness for any particular use of any relevant services and shall have no liability for any matters relating thereto. Eligible Cardholders should contact the Merchant directly for any complaints or disputes regarding any relevant services. 21. In case of discrepancy between the English and Chinese versions of the terms and conditions herein, the English version shall prevail.
